Wah Brass Mill, a production unit of Wah Industries Limited intends to procure Sulphuric Acid (H₂SO₄) 96-98% Pure (Qty 50 MT) as per detail, specs given in the Schedule of Tender attached at page 5. It is requested to submit sealed quotations for the items noted on the schedule of the Tender. Tender will be opened at **1030** hours on **26-11-2025** (Wednesday) and must reach POF Bids Centre through Air mail / courier before 1030 hrs. The tender received late will not be entertained. The bids "By hand" must be received in the Bid center 30 minutes before the time of Bid opening. You may witness the opening of the tender if so desired. If a representative is deputed, he should bring a **letter of authority**. The venue of Tender Opening is **POFs Bid Centre (Room No. 02), Behind Rabta Hall, POF, Wah Cantt.**

1. **SUBMISSION OF TENDER**

1.1 Please quote as per following single stage two envelope method. You are required to quote in two parts: -

a) **Part I "Technical Offer"**: It should exclusively give technical details and literatures/brochures of the offered items; validity date; delivery schedule; and signed undertaking given on the schedule to this Tender Enquiry. It must not indicate price, costs etc. Bid Money of Rs. **150,000/-** should accompany in the shape of **Pay Order** with Technical offer. **Tenders received without Bid Money will be rejected.**

Note: it must not indicate price, costs etc.

b) **Part II "Commercial Offer"**: It should indicate the commercial terms e.g. price, terms of payment, mode of payment, mode of supply. Each part should be placed in a separate sealed cover. The envelopes should be inscribed with: Part I "Technical Quotation without Price" and Part II "Commercial Quotation with Price".

1.2 Only one tender should be included in one envelope. The outside of the envelope should be inscribed with: -

2.0 **GENERAL INSTRUCTIONS:**

- 2.1 The quotation must remain valid for at least 90 days from the date of opening of tenders.
- 2.2 The quotation should hold good for any reduced or enhanced quantity without notice.
- 2.3 Conditional offers or alternative offers are likely to be ignored.
- 2.4 Quotations should be based on "Free Delivery" at Wah Brass Mill Quaid Avenue, (Adjacent to POF Main Gate), Wah Cantt.
- 2.5 The suppliers registered with Sales Tax Deptt are only eligible to participate in the T.E. The competitive supplier shall have to furnish Sales Tax Invoice and Professional Tax Clearance Certificate.

3.0 **TENDER FEE:**

4.0 **BID MONEY:**

- 4.2 Bid Money of the unsuccessful bidder will be returned as soon as the scrutiny of the tenders is completed. Bid Money of the successful tenderers will be retained until the contract is finalized. Bid Money will be forfeited in case the quotation is withdrawn before the expiry of its validity date.

5.0 **PERFORMANCE GUARANTEE:**

- 5.1 The successful bidder will provide Performance Guarantee at the rate of 10% of the contract value in favour of CEO / MD Wah Industries Ltd, Wah Cantt. The Performance Guarantee will be furnished in the form of Pay Order from any scheduled bank. The Performance Guarantee will be submitted prior to the placement of Contract and the same will be returned on satisfactory completion of the contract. In case the firm fails to supply the contracted store / contractual obligations, PG will be forfeited.

7.0. **ACCEPTANCE OF OFFERS:**

7.1 The Right to accept or reject any offer in full or in part, without assigning any reason is hereby reserved.

8.0 **FAILURE TO SUPPLY THE STORES:**

8.1 Performance Guarantee @ 10% of the total value of contract will be submitted prior to the placement of contract. The Performance Guarantee will be returned on satisfactory completion of the contract. In case of failure of the supply, the Performance Guarantee will be forfeited.

9.0 **LIQUIDATED DAMAGES:**

9.1 If the supplier fails to supply the contracted store in-accordance with the delivery schedule as specified on contract, liquidated damages at the rate of 2 % per month or part of the month of the value of the late delivered stores may be levied, but the total damages shall not exceed 10 % of the contract value. However, if the delay occurs due to force majeure or such other circumstances which the purchaser may consider unavoidable the purchaser may extend the delivery period.

10.0 **MATERIAL / STORES:**

10.1 The material / stores shall conform to the specifications as laid down in the schedule to Tender Enquiry.

11.0 **WARRANTY / GUARANTEE:**

11.1 The stores shall be supplied on Warranty / Guarantee subject to Inspection at WBM. Rejected stores will be removed and replaced with the acceptable store by the supplier at his own expenses within specified time.

12.0 **PAYMENT:**

- i) 100 % Payment after receipt and acceptance of stores at WBM, Wah Cantt.
- ii) Partial Supply / Partial Payment is allowed.

Special Conditions for Supply of Sulphuric Acid (H₂SO₄)

- i) Firm must provide test report of acid with each supply.
- ii) The Firm must bring pump and acid resistance rubber hose pipe along with container. Length of pipe to be 60 feet (approx.). Firm's rep. will arrange unloading of Acid.
- iii) Firm reps must be equipped with necessary safety equipment / PPEs.
- iv) Please note that internal diameter of rubber hose pipe that can be fixed with WBM pump is 32mm. In case of failure of firm's pump, the outlet nozzle of container must be able to fix 32mm dia pipe.
- v) WBM will intimate the firm regarding schedule of supply. Delivery of 75 MT will be completed till 31-12-2025.
- vi) Every Time, the container must reach WBM before 10 am (morning). Supply should not be made on Friday & holiday until and unless WBM requires so.
- vii) Firm must have NOC duly issued from Ministry of Narcotics and ensure necessary safety measure for container and its rep during supply of acid to WBM.
- viii) Acid is required in partial supplies.
- ix) Supplies to be made as and when required by user section.
